3 WHEREAS, this matter came on for consideration by the Court upon
4 verified petition for writ of superintending control and request for stay, and
5 responses thereto, and the Court having considered the foregoing and being
6 sufficiently advised, Chief Justice C. Shannon Bacon, Justice Michael E. Vigil,

9 NOW, THEREFORE, IT IS ORDERED that the request to stay the
10 underlying proceedings is GRANTED, and all proceedings in D-506-CV-2022-

12 IT IS FURTHER ORDERED that the parties shall file supplemental briefs
13 in accordance with the requirements in Rule 12-318 NMRA, and that the brief in
14 chief shall be filed **on or before November 3, 2022**, with the answer brief due
15 twenty (20) days after service of the brief in chief, and the reply brief, if any, due
16 five (5) days after service of the answer brief; and

17 IT IS FURTHER ORDERED that oral argument shall be heard on **January**

1 9, 2023, at 1:30 p.m.
