Upon consideration of the Emergency Petition of DELAWARE COUNTY BOARD OF ELECTIONS, and in light of the exigent circumstances, it is hereby ORDERED as follows:

1. The Court approves the relocation of the polling location for Radnor Township Ward 2, Precinct 1 and Radnor Township Ward 2, Precinct 3 from Radnor High School, 130 King of Prussia Road, Radnor PA 19087 to Radnor Elementary School, 20 Matsonford Road, Wayne, PA 19087.

2. The Court approves the extension of voting time by one hour for Radnor Township Ward 2, Precinct 1 and Radnor Township Ward 2, Precinct 3, such that those two precincts will remain open until 9:00 PM.



EMERGENCY ELECTION PETITION FOR RELIEF

Delaware County Board Of Elections hereby petitions the court to allow the polling locations for Ward 2, Precinct 1 and Ward 2, Precinct 3 in Radnor Township to remain open for one additional hour and avers and support thereof as follows:

1. The polling location for Ward 2, Precinct 1 and Ward 2, Precinct 3 in Radnor Township are at Radnor High School at 1130 King of Prussia Road, Radnor PA 19087
2. At approximately 6:00PM that Location received a bomb threat and police were required to evacuate the building.
3. All voting was forced to stop.
4. The Board of Elections arranged for an alternate polling location to be opened at Radnor Elementary School at 20 Matsonford Road, Wayne, PA 19087.
5. Sherriff Personnel are on site to redirect voters and ensure they can get to the alternate polling location.
6. Due to the exigent circumstances, the Board respectfully requests that the Court authorize the polling locations for Ward 2, Precinct 1 and Ward 2, Precinct 3 in Radnor Township to remain open for one additional hour at the new location.

WHEREFORE Petitioner respectfully requests that this Honorable Court enter the attached Order.


