WHEREAS, the Parties in Action No. 7 stipulated to discontinue that Action as against the Orange County Republican Committee, the Orange County Democratic Committee, the Conservative Party of New York State, and the New York Working Families Party as Defendants pursuant to CPLR §1003, leaving Action No. 7 pending only against Kathleen Hochul, in her capacity as Governor of the State of New York, and the State of New York (Doc. No. 62); and

WHEREAS, the Parties in Action No. 1, consented to consolidate Action No. 7 (Doc. No. 62); and

WHEREAS, the Parties in Action No. 6 stipulated to change venue to Onondaga County and desire it to be consolidated with Action No. 1 (Doc. No. 56); and

WHEREAS, the Parties in Actions No. 1 and Action No. 2 (Doc. No. 76), Action No. 3 (Doc. No. 77), and Action No. 4 (Doc. No. 78) agreed to consolidate their actions with Action No. 1 and the Court So-Ordered the requests; and

NOW, THEREFORE, it is hereby

ORDERED, that upon the oral motion by Plaintiff Rockland County and Edwin J. Day, Individual and official capacity as Rockland County Executive to consolidate Action No. 6 with Action No. 1 is GRANTED; and it is further

ORDERED, that the motion by Plaintiffs County of Dutchess, the Dutchess County Legislature, and Susan J. Serino, Individually and as a voter and in her capacity as Dutchess County Executive is GRANTED; and it is further

ORDERED, that the stipulation to discontinue Action No. 7 as against the Orange County Republican Committee, the Orange County Democratic Committee, the Conservative Party of New York State, and the New York Working Families Party as Defendants pursuant to CPLR §1003, leaving Action No. 7 pending only against Kathleen Hochul, in her capacity as Governor of the State of New York, and the State of New York is GRANTED; and it is further
