² On page 10 of the Brief, the Appellants state that “[t]he Agilis Falcon sorts the package by precinct and evaluates the package’s dimensions, including length, height and weight...” That citation does not accurately reflect the record evidence below, which established only that the subject machine evaluates the dimensions of a package for **length** and **height**. Hrg. Tr., App. Ex. C. at A.103.
