**ORDER GRANTING DEFENDANTS' MOTION TO DISMISS**


Before the Court is Defendants' Motion to Dismiss. Because Defendants have taken the position that the challenged law, Act No. 2024-341 (H.B. 100 (2024)),

will not be enforced until after the November 5, 2024 general election, Plaintiffs and all other similarly situated Alabamians are not disqualified from registering or voting by virtue of the challenged law and have the right to register and vote through the November 5, 2024 general election. Therefore, the Court **GRANTS** the Motion to Dismiss.

For the foregoing reasons, it is hereby **ORDERED AND ADJUDGED** that:

1. Defendants Motion to Dismiss is **GRANTED**;
2. Plaintiffs' Complaint is **DISMISSED WITHOUT PREJUDICE AS TO ALL DEFENDANTS**;
3. This action is **CLOSED** and all pending motions are **DENIED AS MOOT**.
