**STIPULATED ORDER RESOLVING PLAINTIFFS' MOTION  
FOR A TEMPORARY RESTRAINING ORDER AND PRELIMINARY INJUNCTION**

This matter comes before the Court on Plaintiffs Millions for Prisoners NM, Tyler Wayne Jackson, Amber D'au Smith, Virgil Dixon and Charles Cadena's motion for a temporary restraining order and preliminary injunction. Having reviewed the motion, legal arguments and substantial evidence, being advised that all Defendants have agreed to the following relief, and good cause having been shown, the Court hereby approves and enters the following Stipulated Order to resolve Plaintiffs' Motion for a Temporary Restraining Order and Preliminary Injunction (filed October 1, 2024). It is hereby ORDERED, ADJUDGED AND DECREED that Defendants

are enjoined to comply with the terms of the following Stipulated Order:

**STIPULATED ORDER**

1. This Court has jurisdiction in this matter pursuant to Article VI, Section 13 of the New Mexico Constitution, and NMSA 1978 §§ 44-6-2, 44-6-9, 44-6-13, and 41-4A-1-13; NMSA 1978 § 38-3-1.1; and NMSA 1978 § 38-1-16. Venue is proper in this Court pursuant to NMSA 1978 § 38-3-1(G)
2. Defendants Maggie Toulouse Oliver, in her official capacity as Secretary of State of the State of New Mexico, and the New Mexico Office of the Secretary of State, (collectively “NMSOS”) agree and are enjoined as follows:
  - a. As of October 1, 2024, the NMSOS has notified the U.S. Election Assistance Commission of New Mexico’s current eligibility requirements.
  - b. The NMSOS will systematically remove all of the registration forms with attestations that reflect the law prior to July 1, 2023 from the agency website and replace all of them with registration forms that reflect the law in effect as of July 1, 2023, including but not limited to the forms at the following URLs: <https://portal.sos.state.nm.us/ovr/VRForms/VRFormEnglishFinal.pdf> and <https://portal.sos.state.nm.us/OVR/VRForms/VRFormSpanishFinal.pdf>. The NMSOS will instruct that the county clerks use only the registration forms that reflect the law in effect as of July 1, 2023. The NMSOS has provided guidance to the clerks instructing them to immediately order the registration forms that reflect the law in effect as of July 1, 2023 if they haven’t done so already, but clerks should still process any registrations received on the old forms.
  - c. The Secretary of State will work with the NM Corrections Department to ensure that any felony records, including but not limited to “not eligible” designations in

the SERVIS Felon Records Search, are limited to those currently imprisoned in a correctional facility as part of a sentence for a felony conviction. The Secretary will mark as satisfied all felony records in SERVIS for individuals who are not currently incarcerated so that they will no longer be marked as ineligible on the basis of felony conviction or incarceration.

- d. To address convictions before July 1, 2023, the NM Corrections Department has prepared an electronic list of every person in a New Mexico correctional facility (including the privately run facilities in Lea County and Otero County) as of October 1, 2024, and will prepare such a list at least monthly, which the NM Corrections Department will transfer to the NMSOS in a format the NMSOS can use and in whatever secure manner the NMSOS provides in order to protect the personally identifiable information of our current inmates as well as to ensure the integrity of the data between agencies. This electronic list will include, among other data, date of birth and social security numbers in order to minimize the chance of false matches with the NMSOS voter file data. Using the October 1, 2024 list, the NMSOS will update the data in SERVIS to clear felony records, including but not limited to designations of “not eligible” for those individuals not currently incarcerated. The NMSOS estimates that it will be able to accomplish this task by 12:00 p.m. on October 8, 2024. The NMSOS will continue to use the monthly lists provided by the NM Corrections Department to cross-reference against and correct their records at least monthly until an automated system is in place.
- e. On Friday, October 4, 2024, the NMSOS sent the attached guidance to all county clerks. Ex. A. By October 7, 2024, the NMSOS will send the county clerks lists of denied registrations to be reprocessed.

- f. The Secretary of State has no legal authority regarding and cannot speak to any statutory obligations the NM Corrections Department may have regarding the implementation of NMSA § 1-4-27.1. However, the Secretary of State agrees to long-term collaboration with the NM Corrections Department to ensure the Secretary of State's duties under NMSA § 1-4-27.1(C) are fulfilled with respect to any data sharing necessary for the implementation of NMSA § 1-4-27.1. The Secretary of State agrees to work with the NM Corrections Department and any relevant vendors to implement by June 30, 2025, a mechanism for seamless exchange of data pursuant to NMSA § 1-4-27.1(B) and (C), with any deadline subject to extensions by the Court in good faith.
- g. NMSOS will work to identify registrations that were denied on the basis of felony data but that have no indication of incarceration. NMSOS will send each county clerk a list of registrations that were denied after July 1, 2023, based on felony data and direct the re-processing of those registrations based on the updated SERVIS records and release information provided by DOC.
3. Defendants Alisha Tafoya Lucero, in her official capacity as Secretary of New Mexico Corrections Department, and the New Mexico Corrections Department agree and are enjoined as follows
- a. The NM Corrections Department has prepared an electronic list of every person in a New Mexico correctional facility (including the privately run facilities in Lea County and Otero County) on October 1, 2024, and will transfer this data to the NMSOS in a format they can use and in whatever secure manner the NMSOS provides in order to protect the personally identifiable information of our current inmates as well as ensure the integrity of the data between agencies. This electronic

list includes date of birth and social security numbers in order to minimize the chance of false matches with the NMSOS voter file data. The NM Corrections Department will continue to transfer this data to the NMSOS at least monthly until the mechanism referenced in paragraph 3(c), below, is in place.

- b. The NM Corrections Department will also immediately set up and staff a hotline that county clerks and their staff can call when processing online, mail, or VRA registration forms to confirm whether someone is incarcerated in a NM state correctional facility. That hotline will be staffed between the hours of 8:00am to 5:00pm, Monday through Friday through November 5, 2024, in case questions arise during the processing of registration applications prior to the October 8, 2024 deadline or concerning the review of previously rejected registrations between now and November 5, 2024. Pursuant to NMSA § 1-4-27.1(D), clerks or their staff are not legally allowed to deny same day voter registrations on the basis of suspected incarceration during in person, same day voter registration at polling places and so this hotline should not be promoted or used for that purpose.
- c. The NM Corrections Department has no legal authority regarding and cannot speak to any statutory obligations the NM Secretary of State may have regarding the implementation of NMSA § 1-4-27.1. However, the NM Corrections Department agrees to long-term collaboration with the Secretary of State to ensure its duties under NMSA § 1-4-27.1(B) and (C) are fulfilled with respect to any data sharing necessary for the implementation of NMSA § 1-4-27.1. To that end, the NM Corrections Department agrees to work with the Office of the Secretary of State and any relevant vendors to implement by June 30, 2025, a mechanism for seamless exchange of data pursuant to NMSA § 1-4-27.1(B) and (C), with any deadline

subject to extensions by the Court in good faith.

4. Defendants Linda Stover, in her official capacity as County Clerk for Bernalillo County, and the Office of the Bernalillo County Clerk agree and are enjoined to:
  - a. follow the guidance and instructions of the NMSOS pursuant to the letter referenced in Section 2(e), above.
  - b. reprocess the registrations of the four individual Plaintiffs within 48 hours of the entry of this order.
5. The litigation of this case is hereby stayed and all deadlines are hereby suspended pending a status conference by the Court with all parties to be held during the last half of January 2025. The purpose of the status conference will be to report to the Court on: a) compliance with this Stipulated Order, b) the progress made by the NMSOS on amending its regulations to comply with the New Mexico Constitution and NMVRA so persons with past felony convictions who are not incarcerated do not have to appear in person in order to register to vote, c) the progress made by NMSOS and the NM Corrections Department to achieve the seamless exchange of data required by the NMVRA and this Order, and d) such other matters raised by the parties.
6. This Court shall retain jurisdiction over this matter and all parties until all terms of the agreement have been completed.
7. This Stipulated Order shall be effective immediately.

### Processing Voter Registrations that Match to the Felony Database

As you know, 2023 legislation allowed individuals incarcerated as a result of a felony conviction to be eligible to register to vote upon release from a correctional facility. This guidance shall serve to reemphasize the provisions of 1-4-27.1 NMSA 1978.

1. **These individuals shall be provided with an opportunity to register to vote during the reentry phase of their sentencing.** SERVIS has been updated such that a release date is captured at the facility, and these applications remain in suspense until the release date is realized. Registrations pursuant to this new law appear in SERVIS with codes that identify specific correctional facilities (1-4-27.1 (B) NMSA 1978).
2. **These individuals can also appear in-person and therefore confirm that they are no longer incarcerated - regardless of any information to the contrary in SERVIS.** We have included the exact statutory language below.

*Notwithstanding a person's status in the statewide voter registration electronic management system, a voter or a qualified elector who appears personally before a county clerk, the clerk's authorized representative or a precinct board member, at an office of the motor vehicle division of the taxation and revenue department or at a state agency that provides public assistance or services to persons with disabilities is presumed to meet the eligibility requirement of non-imprisonment for voting and registering to vote pursuant to the provisions of this section. (1-4-27.1 D NMSA 1978).*

3. **The attached voter registration form with the correct attestation was provided to you in 2023 and should be the form that is being utilized.** You should have received this version of the voter registration form for any orders you made from GSD after August 18, 2023. If you have not ordered the new forms, you should order the new forms immediately. In the meantime, when individuals attempt to register using an old form and have questions about the outdated attestation, you should clarify that it no longer accurately reflects the law because felony conviction no longer makes a person ineligible for registration and voting as long as they are not incarcerated.

In addition to the data we regularly receive from the Department of Corrections and the Administrative Office of the Courts, etc., we recently received updated data from the Department of Corrections providing a list of individuals who are currently incarcerated as of October 1, 2024.

We are actively working to update SERVIS with the updated incarceration data, so that individuals who are not incarcerated currently are reflected as eligible to register in SERVIS. When that update is complete, these individuals will not appear as a match to the felony database during registration processing.

#### **NEW GUIDANCE**

When a voter matches for a felony conviction, unless you have evidence that the individual is physically incarcerated, they should be cleared and processed. Therefore, you will need to:

1. Call the Department of Corrections at 1-866-416-9867 and ask if that person is incarcerated. This hotline will be open 24 hours a day. You may call the NM Corrections Department hotline if you have any concerns when processing online, mail, or VRA registration applications to confirm whether someone is incarcerated in a NM state correctional facility.
2. After conducting that phone call, you should receive documentation from the Department of Corrections via email of the information provided over the phone, and you should upload that documentation in the voter database.
3. If DOC has confirmed the individual is not incarcerated and provided documentation, the application shall be processed.
4. **REMEMBER:** If the person is registering in person or their registration came from one of the in-person methods listed in the “Clear and Process” section below, they are legally presumed to meet the eligibility requirement of non-imprisonment and so must be cleared and processed regardless of their status in SERVIS.

In addition, and in an effort to ensure that all eligible voters are registered properly, it is necessary to have a second look at registrations that have been received on or after July 1, 2023, where the voter record was updated to reflect a Not Eligible/Felony Conviction Status. Clerks should reprocess and approve those registration applications from individuals who have no evidence of incarceration. If SERVIS indicates the individual is incarcerated, this will require use of the DOC hotline above to confirm. Without confirmation from DOC that the individual is incarcerated, the This secondary review must be completed by October 18, 2024.

Updated technical guidance is also included below.

### **TECHNICAL GUIDANCE**

#### **Reprocessing of voter registration applications previously rejected.**

**Deadline to complete work in SERVIS: October 18, 2024**

**Instructions:** Your county will receive a list of all impacted voter records meeting the requirements for review from the Secretary of State’s Office.

Each record should be carefully reviewed to determine whether the voter registration should remain Not Eligible or should be updated to reflect Active Status. Use the matrix below to make your determination.

#1	Field Correction	
#2	Death/Felon Checks	✓
#3	Verify Residence Address	✓
#4	Assign Precinct Part	✓
#5	Update Voter Record	

**Step 1:** Check the images tab. Is there a completed voter registration application (from any source) that is dated on or after July 1, 2023?

- If yes, proceed to step 2.
- If no, the record should remain as-is and the voter must submit a new voter registration application.

**Step 2.** Using the most recent voter registration application dated on or after July 1, 2023, Click the “Update Voter” button and select “Field Correction” in # 1. Click # 2: “Death/Felon Checks”. Is there a match at the bottom?

- If yes, and the match appears to be the same person, refer to the full guidance document provided and proceed with contacting the DOC hotline number to obtain confirmation as to whether the voter is incarcerated.
- If no, Update the Registration status to Active and update the Registration Status Reason to Active Registrant.

**Step 3.** Proceed to # 3 in the voter registration flow in SERVIS to precinct the voter. Make any additional necessary updates as reflected on the application you are processing.

**Step 4.** Click # 5 – Update Voter Record to complete the registration update into Active Status. This voter will receive a standard VIC at the SERVIS mailing address (or residence address if the mailing address is blank.)

**Step 5.** Don’t forget to print and mail the VIC.

### **Clear and Process**

The new law requires you to assume that any registrations that originate from these sources are acceptable to “clear and process.” Clear means you may pull up the record in the SERVIS Felon Records Search and check the “Satisfy” box next to the felon record. Once all related felony records have been satisfied, you may then proceed to process the voter registration application.

“Clear and Process”

- MVD (electronic or paper) – Except if Agency code is 34W (MVD-Online)
- In Person (without VRA number)
- SDR
- Any agency code

Steps to Clear:

When processing your voter registration, at Step 2: (Death/Felon Check) you may run across a strong or weak match to the Felon Database. When this happens, first determine whether the match is the same person who has submitted the registration.

If yes, you will need to “clear the felony” before proceeding. Click County Utilities→Felon Record Search and find the felon record.

Click Edit next to the record you need to clear.

Now you can continue to process your voter registration. Click Step 2: Death/Felon check again and you should see no matches.

### **Match and Mail**

Applications received from these sources will require additional research to confirm incarceration.

- OVR
- Mail
- In-Person (with VRA number)
- MVD with code 34W (MVD Online)

New Steps:

When your Death/Felon Check produces a match to a felon record, review the matching criteria to determine if the match is the same person that submitted the voter registration application.

If you determine it is a match, contact the DOC hotline at: 1-866-416-9867.

Review the record with the DOC agent and receive confirmation as to whether the voter is currently incarcerated.

If the voter is confirmed to NOT be incarcerated, they are eligible to vote. You will receive written confirmation via email from the DOC agent and that must be attached to the voter record.

Once you receive your confirmation:

1. Save the email confirmation as a pdf, then attach it to the voter record in the images tab. Use the form type "Court Document" and add a note DOC Confirmation.

This updated notice will direct the registrant to submit a new voter registration application using one of the acceptable sources.

Use the same process to Match. If you determine the felon record is the same person as your registrant, and have confirmed that the voter is incarcerated, click “Match” next to the records that match and “Ignore” next to records that do not match. Proceed to step 5 “Update Voter” to generate the appropriate letter. Do not forget to attach your image, your DOC Confirmation, and send the notice from your SERVIS Home Screen.

Voter registration applications received from a correctional facility as part of an inmate’s reentry phase will be noted with a source code beginning with CORR.

These records will have the inmate’s release date on the Voter Registration image as the signature date.

When presented with one of these records, the status should be set to “Suspense” and the status reason set to “Pending Release” if the release date is in the future.

The actual release date should be input into the release date field. Upon the release date, the record is automatically updated to Active status and a voter information card is sent even if the address listed on the registration form is a correctional facility.
