**PETITION FOR EMERGENCY RELIEF**

**AND NOW**, come Petitioner, Cambria County Board of Elections, by and through its undersigned Solicitor, Ronald N. Repak, Esquire, to file the within Petition for Emergency Relief averring in support thereof as follows:

1. The Electronic Voting System (“EVS”) used in Cambria County experienced a software malfunction at the start of voting on November 5, 2024.
2. The EVS malfunction prevented voters from scanning their completed ballots.
3. The malfunction caused voter confusions, long lines of voters, and many individuals left the polling locations without casting a ballot.
4. The Board of Elections was unable to timely fix the EVS software malfunction which resulted in hours of delay in the proper operation of the EVS. As of the filing of this Petition, the problem has not been corrected and the EVS is still not properly functioning.
5. The EVS software malfunction threatens to disenfranchise a significant number of voters in Cambria County and this petition is seeking to ensure all voters are provided an opportunity to vote.

**WHEREFORE**, Petitioner respectfully requests that this Honorable Court enter an Order extending the voting in Cambria County from 8:00 p.m. to 10:00 p.m., along with any other relief deemed appropriate by the Court.
